WHEN IS ENOUGH, ENOUGH? A study

conducted by the NY Times showed that the median pay for the top executives at 200 companies in 2010 was \$10.8 million. This reflects a salary increase of 23% from 2009. The average American's pay increased by 0.5% in 2010 while many other Americans had their salaries cut or frozen and their 401(k)s temporarily halted for months. They didn't earn the 23% raise the top executives received as members of the good ole boy club taking care of each other. Most of these companies had a good year but it wasn't due to the brilliant strategic thinking of their CEOs, it was due to the economy improving in 2009 & 2010. In 2010, CEO Leslie Moonves of CBS Corp. was paid \$56.9 million; CEO Philippe Dauman of Viacom Inc. was paid \$84.5 million. Is anyone worth \$84.5 million a year. If I had stock in either of these companies, I would sell it in protest. For Corporate Boards to grant and CEO's to accept these ridiculous salaries is just plain greedy when the unemployment rate is 9.1%, 13.9 million workers are unemployed and many additional Americans are struggling to make ends meet. The great danger is that excessive CEO compensation, especially at a time of economic hardship for so many, will make Americans more cynical about corporate top management and corporate America, in general, which may ultimately harm the American free enterprise system. This information was obtained from Pensions and Investments Magazine.

The Illinois veto sessions begin the weeks of October 25<sup>th</sup> and November 8<sup>th</sup>. Please contact your State Senators and State Representatives directly or by telephone, 888-412-6570 and ask them not to support any legislation that would impair or diminish retiree benefits. We can thank the chairman of the Social Security Committee for another year of disappointment because H.R.1332, the Social Security Fairness Act Bill, to repeal the Windfall Elimination Provision and the Government Pension Offset Act were never called out of committee for a vote.

I received an email from Police Constable 755, Alan Paul who retired in 1999 with 30 years of service. He is the social secretary and newsletter editor for the Cambridgeshire Branch of the British National Association of Retired Police Officers (NARPO). The last newsletter contained a letter from Attorney Clint Krislov. He is the lead court appointed attorney on the Korshak Decision that concerns medical benefits for police and fire retirees plus retirees from three other pension systems. Over 300 law enforcement retirees contacted his office prompting him to attend our May meeting to update us on the case and identify retirees who best represent the majority for presentation of the case for renewal. Questionnaires will be sent out this fall or spring to assist his office in preparing the

Recently, two bills in Illinois which would have affected workers pensions were beaten down due to the vast number of pensioner calls to elected officials. I understand the calls were coming in so fast in such great numbers that the staff in Springfield had to use personal cells phones to make outgoing calls. This is a most effective way to be heard. Elected officials work for us, the people. This fight is ongoing and will continue in the fall veto session starting in October.

There is an anti-public sector union sentiment gaining strength across the United States. Remember what our labor movement was like without a union. In the police department if you were disliked by a boss you could be dumped to a rotten assignment, watch, and place without recourse. Consider the rules in place for officer safety won by union representation. Union contracts have saved lives from the bowels of coal mines to the top of skyscrapers. Babyboomer retirees have the biggest voting blocks in the United States. Stay aware of what's happening both locally and nationally. Call or write your State and Congressional elected officials and insist that they take action on our behalf.

Some of us have Police Department Identification cards that are worn, cracked and need to be replaced. Current Chicago Police policy demands the retiree appear in person at the Personnel Department on 35<sup>th</sup> and Michigan to have a new card issued. I contacted four departments regarding their policies on replacement of identification cards. Two responded. One requires the retiree to come in and the other said it can be done by mail. This issue has been discussed Chicago Sergeants Association, and one suggestion was to have the retiree submit a photo with a notarized application, and the old identification card via certified mail to police headquarters accompanied by a check to cover the cost of returning the new identification card via certified mail with a return receipt. 
