## Just a Thought... By Russ Schaefer, 1st Vice President, RCPA

Sooooo It has come to my attention that a number of our Pension Fund Annuitants have no idea as to what the -\$21.00 or -\$55.00 in the December 2020 Earnings Statement from the Pension Fund represents. And although it would appear to be a deduction it is not a deduction but in fact it represents an earning that we have been getting in our checks for some time. Take a moment and read the following information that I recovered from the Independent Auditors Report of the Pension Fund Dated December 31, 2019 and the entire report is available on line at the Fund's Website. I also suggest that all of you take the time to look at this full Auditor's Report. Some of it is difficult to read and understand but the areas of true numbers stand out as to what the expenses and also the liabilities are relative to OUR Fund. Knowledge is Strength and Power!

PAGE 46 - NOTE 13 CONTINGENCIES In July 2013, a group of plaintiffs purporting to represent annuitants in four Chicago public pension funds filed a civil action, Underwood v. City of Chicago et. al. (13-CH-17450; 1-17-162356), seeking class certification and an order requiring the City and the defendant pension funds to continue subsidizing annuitant healthcare insurance premiums past the June 30, 2013, statutory expiration date. Following years of litigation, on June 29, 2017 the Illinois Appellate Court issued an order which in part affirmed the Circuit Court's dismissal order and held: (i) annuitants did not have a right to lifetime healthcare coverage; and (ii) the subsidies pursuant to the 1983 and 1985 amendments is the sole benefit protected under the pension protection clause of the Illinois Constitution. Accordingly, those eligible annuitants in the Appellate Court expanded class, and as further defined after remand in the Circuit Court's February 28, 2019 order, are entitled to continue to receive the 1983 provided subsidies (related to the police and fire funds) of \$55 per month if non-Medicare eligible and \$21 per month if Medicare-eligible. While the plaintiffs continue to raise certain objections, the pension funds nevertheless, in accordance with the rulings made, have commenced payment of the subsidies to those defined eligible annuitants as of January 1, 2017 and thereafter.

I understand there are about 86 Sergeants retiring in 2020 and maybe 12 Lieutenants as well as a few Captains. Those retiring below the rank of supervisors are extensive and accumulating daily. Previously I reported is that the pension fund is paying out to more retirees than there are actives paying into the fund, and it's getting worse. These are totals before 01 January, and many retire on the 15th of January. The numbers do not look good. Prepare for the worst and hope for the best.

Illinois passed a law allowing Chicago to build a casino, but Mayor Lightfoot has been dragging her feet on building one. Many thought the perfect spot was the old Michael Resse Hospital property as it is close to the convention centers, had great ground transportation by land and water to downtown, but the Mayor blew that away and it's gone to private developers. She was talking about placing the casino

on the west side or the south east side right next to the Indiana casino. There is no property on the north side, and the only property that might be useful is the railroad property just south of down town, or Northerly Island (aka Miggs Field). So, as the Mayor and the alder people fiddle around, we watch our pensions continue to be defunded.

Recently there was a proposal to tax the Michigan North Ave Merchants for protection they have not received and the merchants would simply pass the cost on to shoppers. So taxing the victims is better than arresting the offenders. Mayor Lightfoot and the Cook County ASA Foxx, refuse to allow the police to uphold the law apparently through orders to the Police Superintendent. But wait, it was the people of Cook County who voted these folks in. The governed get what they deserve, though due to cemetery and other illegal votes, I am not sure about the last election. What next????

Crime is up in Chicago, and the police enforcing the law fear punishment for doing their job, so they don't. Look at Car-jackings, up over 150%, for example. If an officer stops a car, they might be accused of profiling the driver and if there is a chase, which often ends badly with people hurt, it's the officers who are to blame. Officers hesitate to do their job because they feel betrayed by their leadership. Sergeants too are rethinking their positions, and lawabiding tax-paying citizens suffer as victims and their home values diminish.

Businesses are closing because of the Chinese virus restrictions, destruction and looting of their property, and the lack of law enforcement. Consider this; some of the corporations that are part of our pension fund investments are closing their Chicago doors, meaning our investments lose money. So, we must bug our elected officials until they do something to protect our future pension checks. Keep safe. Spring is just around the corner! I don't know if that is good or bad.
