So five years ago I sat down to lunch with an old friend, Paul. Paul was a LEO and we shared many laughs and cocktails together over the years. In fact Paul was a committed alcoholic and he refused to cut his intake of alcohol even to an accepted level of consumption. At the time he told me he had been diagnosed with Alzheimer's disease, sadly I had already known that his wife Mary was suffering with Dementia and yes, Mary was also an alcoholic. Dementia is a general term for a decline in mental ability severe enough to interfere with daily life. Alzheimer's is the most common cause of Dementia, accounting for 60-80% of Dementia cases. Alzheimer's is a specific disease. Dementia is not.

So what might have caused these issue for my friends? Study reviews found that individuals who drank heavily over a long period of time or who are binge drinkers were more likely to develop Alzheimer's or any other form of Dementia than those who engaged in moderate alcohol consumption. How can alcohol damage the Brain? Simply, those people who drank heavily over long periods of time are more likely to have a reduced volume of the Brain's white matter which helps to transmit signals between different regions of the Brain and this of course can lead to serious consequences for healthy Brain function.

Paul wanted to donate his organs and his Brain for research. Paul's son told me that his critical organs were so damaged by his alcohol consumption as not to be suitable for donation but his Brain has gone on to help us through research. Both healthy brains and those affected by diseases such as Alzheimer's are needed for research. Comparing healthy brains to those affected by neurodegenerative disease is a critical method for researchers to learn more about the underlying biology that causes brain disease.

The National Institute of Health funds many research centers in the U.S. that accept Brain donations. The National Institute on Aging supports more that 30 Alzheimer's Disease Research Centers (ADRCs) across the country that conduct Alzheimer's research. The NeuroBioBank program includes six banks that accept donations with or with out conditions affecting the Brain. Think about these resources and discuss them with your family before the end game arrives in your life. I am so proud of my dear friend Paul, always a giving person in life and that he was able to make that generous decision to help others, before he couldn't. Paul and Mary's story can teach us one good lesson, that of alcohol moderation.

Since last year there has been a huge increase in shootings and car-jackings. The offenders are in vehicles. What's the best way of stopping them? You know the answer; stopping cars, who wants to do that because you're likely to become an offender if the stop goes south. When was the last time you heard a chase? Regardless of the conclusion of the chase, it's the officer who will take the blame if something negative happens. ECON 101 and PSYCHE 101 both teach that behavior punished diminishes and behavior rewarded increases. Do thugs feel rewarded when their violent behavior goes unchecked and unpunished? Either city, state and county leadership are stupid or they are intentionally using a Marxist playbook. Read up on the Ukrainian Kulaks under Stalin. Many politicians and others are happy. However, even the media is sad because that's where they got much of their information. But there's a few honest reporters left; CWBCHICAGO.COMand The Chicago Contrarian and Heyjackass.com. The Contrarian recently did two well deserved damning pieces on David Brown. They will keep you up to date on judges that give low bonds, felons out on low bonds that commit more felonies, and murder and mayhem unreported in the mainstream media. Check them out.

Recently the City Inspector finally announced that the Department and the City screwed up this past summer with the riots and looting. He said that the City had no plan. Yes, there was a plan, and we retirees know it. In summary the police were set up by companies, transported by buses, plastic ties used for cuffs, prisoner vans immediately available, offenders transported to areas, detectives made out arrest slips and complaints, and the offenders housed pending a court appearance. Area 1 was able to hold at least 300 prisoners including the County cells. Further, there are the other areas with holding facilities. Mayor Lori did not want to hurt anyone's feeling so she told her employee, Superintendent Brown, to CHILL. All it cost her was a bunch of police officers hurt and millions in damage to city businesses. No big deal for her and she refuses to give police a contract.

Oh yes, then this; the Illinois governor signed the 700-pageCriminal Justice Reform Bill HB-3653 and Chicago's Lightfoot wants to pass a similar, but more restrictive ordnance. Here are some of the highlights. The State Bill:

- no cash bail
- all must have body cams by 2023
- if info on body cam is not in written report the RO may be charged with class 3 felony
- restrictions are placed on when armed and/or fleeing felons can be shot, tased and more.

Re: Chicago's Proposed ordinance:

• Lt. must go on raid, deputy chief must sign warrant, execute warrants only between 9 AM and 7 PM, no more no-knock warrants, must wait at least 30 seconds after the knock, cannot question children, and property damage must be at a minimum. There is much more to both the state and city regulations, and I suggest looking them up on the internet for a better understanding. The bottom line is that police tools are greatly reduced rewarding criminals by giving them the opportunity to operate freely, and put police lives in danger.

Enough bad news for now; I hope that everyone and everything will return to a healthy normal. This is written in March. I wonder if the Department will allow

the St. Jude ceremony/parade this year?
